SUBJECT: Rate Increase Notification

Upon examination of current financial requirements and due to the increasing costs of operating and maintaining the water system, the Board of Directors has approved the increase of water rates.

The effective date of the rate increase will be the water usage period beginning April 10<sup>th</sup>, 2023 and will be reflected on May 2023 water bills. Existing and new water rates and fees are shown below.
